FRIENDLY SOCIETIES

The Friendly Societies Act 1829 pre-dated the first Building Societies Act 1836. The first Building Societies were in fact registered under the Friendly Societies legislation, and are still responsible to the Registry of Friendly Societies. The first Building Societies Act in its preamble referred to groups of people "principally among the industrious classes". It is generally accepted that the tremendous growth of Building Societies (certainly in the numbers of Building Societies) was substantially due to the eagerness of the people to acquire a small property so as to become "Forty Shilling Freeholders" and thus have a vote. The first "Building Society" was, however, established about 1775 near Birmingham.

Friendly Societies at Wheatley in the early and mid-nineteenth century.

The old records of the Friendly Societies are now stored (so far as they exist) at the Public Records Office in Kew. In the case of the Wheatley Societies, these consist almost entirely of the Society's first Rules, as registered, with, in some cases, notice of the change of meeting place, or appointment of new Trustees. The papers are registered under the Number FS 1 plus the individual piece number, obtained from the index book.

The following extracts have been extracted from rather long Rules, in the hope that these will be of more general interest:

"Wheatley Associated Providential Benefit Society," (Register No. 11) which met at the White Hart Inn, Wheatley, Oxon. "Instituted" on Easter Monday, April 4,1831. Held at Mr. Edward Robbins, The White Hart Inn, Wheatley.

..... to prevent imposition as much as possible, and to secure a fund for the support of its members in sickness and infirmity and for decently burying its Membersmeetings....in the Club Room at the White Hart. .. AW- allowance in sickness £6 allowance for burials. Certificate of illness to be signed by the Father of the Club (who was Edward Robbins) and to be signed by the Minister or Churchwardens, or some of them.

Rule 25 - any member calling another member by any Nick Name (during business) excepting his Christian name or Surname in the Club Room - fine 3d.

Rule 36 - The "Club" to remain so long as there is £50 in the box and three members.

(The above Rules were certified by the Registrar of Friendly Societies, but surprisingly they are also endorsed "Rules allowed and confirmed by W. H. Ashurst, Oxon, Trinity Sessions, 1831.

"Friendly Society" (no other name!), Crown Inn, Wheatley (Registered No. 101). Rules - begun 5th December, 1823. Held at the Crown Inn, Wheatley. Committee to consist of fifteen persons. Trustees: John Slatter of Rose Hill, in the County of Oxford, Gent., John Cooper of Wheatley, Gent., and Joseph Cooper, Wheatley, Brickmaker and farmer.

- Rule 7 Every new member to pay 5/- on admission.
- Rule 12 No member under benefit to be allowed at a Pub. drinking...
- Rule 14 No person having Venereal Disease shall receive any benefit....

Rule 16	Every member living within one mile of the place of burial of another member is expected to attend the funeral (unless he died of the small box), two abreast, in order as their names are placed in the club book. Any member not attending such funeral shall at the next quarter might after burial pay 1/- to funds.
Rule 17	If any member has the small pox he shall be allowed one guinea during the continuance of
	his distemper and no more.
Rule 20	Every member shall keep his seat at business meetings (or be fined 6d)
Rule 23	The name of God shall not be taken in vain.
Rule 24	Any member swearing or using vile expressions such as 'damn it' or propose any wager, shall be fined 3d.
Rule 36	Any member of the Committee revealing anything said at a Committee meeting so as to cause animosity - fined 2/6d
Rule 41	Disputes - to be settled by the Justices as Arbitrators.

Rules of the King and Queen Friendly Society, Wheatley (Reg. No. 238) include:

- Members entering the Club Room and not paying their money fine one shilling
- Rule 21 members making false representation to be expelled.

NB The broad framework of all the rules seems to be much the same and there was obviously an official model for guidance. The rules of the King and Queen Soc. resemble the others in substantial measure.

Rule IX Age of admission 15 to 25 years

Rule XII Sickness pay ... sick, lame or blind so as not to be able to follow his regular calling or workten shillings benefit per week, not to exceed 52 weeks

Rule XIII Fines for working when on the box.

There are then an additional set of rules (but in the same rules book), which include:-

Rule 111 Officers...... Steward to receive contributions and pay the sick ... and be responsible for any deficiency in the accounts.

Rule IV Duties of Officers: to meet in the Club Room on first Tuesday in every month at 7 pm, May to September, and at 6 in the evening October to April If either Steward absent - fine 1/-

Rule IX Age of admission: 15-45 years

Rule XVI Death (after 18 months in the Society) - £4 to be allowed. Every member living within one mile is expected to attend the funeral (unless he died of the small pox) two abreast, in order as their names are placed in the club-book. Each member absent to pay on the next quarter night after burial, 1/- to funds.

Stewards allowed use of hat-bands and gloves at such funeral.

Rule XVII

Rule XIX

Members (of 18 months' standing) allowed £2 for burial of wife.

Behaviour of members: that if at any meeting of this society .. .any member shall be intoxicated, use scurrilous language, reflect on the character of any member, strike, seize by the collar, or make use of any threatening language to the Stewards, or any member, he shall for the first offence pay a fine of 2/6, and for the second 5/-, and for the third be excluded.

Rule XX Fines for intoxicated members 6d (Officers 1/-)

Rule XXI Conduct of members: any member called to order by the stewardand

continues...fined 6d

Rule XXIV fines for vain expressions......any member using the name of God as a vain expression during club hours - fine 3d

Rule XXV If any member shall lie, curse, swear, or use vile expressions, such as

"damn it", or propose any wager - fine 3d

Rule XXVII The Annual Feast: on Tuesday in Whitsun week a feast shall be provided by the Stewards - no part to be paid from funds. No member to partake

until he has paid his money.

Rule XXXIII Admission of strangers...... not permitted until after the business finished.

Rule XXXIV Duties of committee: 1/- fine for non-attendance.

Rule XLIV Disputes to be settled by five arbitrators. Appointment of a Surgeon Rule LI

The funds to be proportionately divided according to the number of months each person has been a member.

(N.B. All members of the Society signed, except only one!)

As a matter of interest, I noticed in the Index of Oxfordshire Friendly Societies, a Society called "The Garibaldian Friendly Society" (of Goring, registered 1861. Another Friendly Society is registered as 'meeting at Mr......'s factory.
